Why have Precinct Reorganization?

- *The current Oconee County Republican Party (OCRP) 2022-2024 was a majority of **moderates/RINOs** and as a result, they rejected passing of the following resolutions:*
 - A resolution to support the South Carolina Freedom Caucus in their fight against oppression from the Republican Caucus, including requirement to sign a loyalty oath and non-transparency agreement regarding social media posting of the voting tally board.
 - A resolution to support our county councils efforts to pass a Conservative Budget measure for county government that limited spending increases to population change and inflation change.
 - A resolution to reform SC Judge selection to keep legislators from appointing their buddies.
 - A resolution to interpret the County Bylaws as allowing the addition of new voting precinct members during the current cycle to expand party membership.
 - A resolution to “close” SC Republican Primaries so that Democrats and Independents could not participate in, and have influence on, what Republican is picked to run for office.
 - A resolution to censor OCRP Chairman Jim Mann for colluding with OCDP Chairwoman Jody Gaulin to primary out true Conservative Candidates for county council and D2 State House Representative (video receipts were provided)

What is Precinct Reorganization?

- Takes place in March of every other year (non-election) for the purpose of organization only (SCGOP Rule 5-b-1)
- Building block leading up to County Convention (April) then to State Convention (May)
- You qualify to be a precinct member if you are registered to vote in your precinct ([see your voter id card](#) [or SCVOTES.org-voter info](#))
- Our **Reorg** date will be Saturday, **March 15th** – 9am check in (be there earlier if you can), 10am start (doors may close!) – Gignilliat Center OR Remote locations for many (see list)
- IF YOU MISS REORG, there is Reorg **makeup** Saturday, **March 29th** – Gignilliat Center
- Important!: New officers and delegates are elected at Reorg on March 15th unless no one shows up for the precinct!

Arrival and Sign-In

- Check-In (Saturday, March 15th, 9am)
- There will be some kind of check-in desks for each of the precincts, usually with a person there covering two or three precincts if at Gignilliat
- They will:
 - Verify Voter Registration Number
 - Verify your Address
 - Give you a triplicate FORM 1 and a County Packet
- You will be directed to the precinct meeting location for your precinct

Description:
During ReOrg: Precinct votes for the number of Delegates & Alternates as determined by most recent election precinct voter turnout
During County Convention: Votes on County Officers & County Delegates to the 2023-24 SCGOP Conventions. - Attends precinct meetings as a voting member

Description:
During ReOrg: Fills out a SCGOP Form1 & turns it in. Votes on Precinct Officers & Delegates to the County Party Convention.
For the 2023-24 Term: Attends Precinct Meetings as a voting member

Description:
During ReOrg: Typically voted in during the bi-annual County Convention
For the 2023-24 Term: Representatives of the County party
- Responsible for conducting County Executive Committee meetings & business
- Attends all SCGOP State Committee meetings in Columbia
- Coordinates Oconee delegation to attend SCGOP State Conventions in Columbia
- Additional County Officers will be elected by the Executive Committee after the bi-annual County Convention

Description:
Typically voted in during the bi-annual County Convention
For the 2023-24 Term: Attends all SCGOP District & State Conventions in Columbia

Description:
During ReOrg: Precinct votes for one County Committeeman
For the 2023-24 Term: Votes on behalf of the precinct at County Executive Committee meetings

Description:
During ReOrg: Precinct votes for as many officer positions as the precinct determines is appropriate
One person may hold more than one officer position only if there are not enough participants in the Precinct ReOrg
President: (once elected) Fills out SCGOP Form2 & turns it in.
For the 2023-24 Term: Conducts precinct meetings & business

Chairman's Introduction

- Once at your precinct meeting location, at approximately 10am, the Current OCRP Chairman (or his precinct level designee if remote location) will call the meeting to order to speak;
- Welcome and Introduction of process (10am)
- Prayer
- Pledge of Allegiance
- Republican Creed
- Read the Letter from State Chairman Drew McKissick
- Release everyone to allow precincts to conduct their business as needed at their station

Precinct Meeting – Fill Out Form 1 to Join Precinct

- Ensure all prospective precinct members present before starting precinct meeting
- Current Precinct President calls meeting to order and if not present, current Executive Committeeman calls meeting to order
- Current Precinct Secretary takes minutes
- Delegate allotment is based on the June 2024 South Carolina GOP Primary (see list)
- If precinct NOT organized, a temp president must be chosen to run meeting and temp secretary to record minutes
- Everyone fills out Form 1 by providing their voter and contact information – DO NOT CHECK ANY BOXES YET!
- Put your name on separate signup list
- Motion to accept all people present as FORM 1 MEMBERS
- You are now a member of precinct and SC Republican Party!

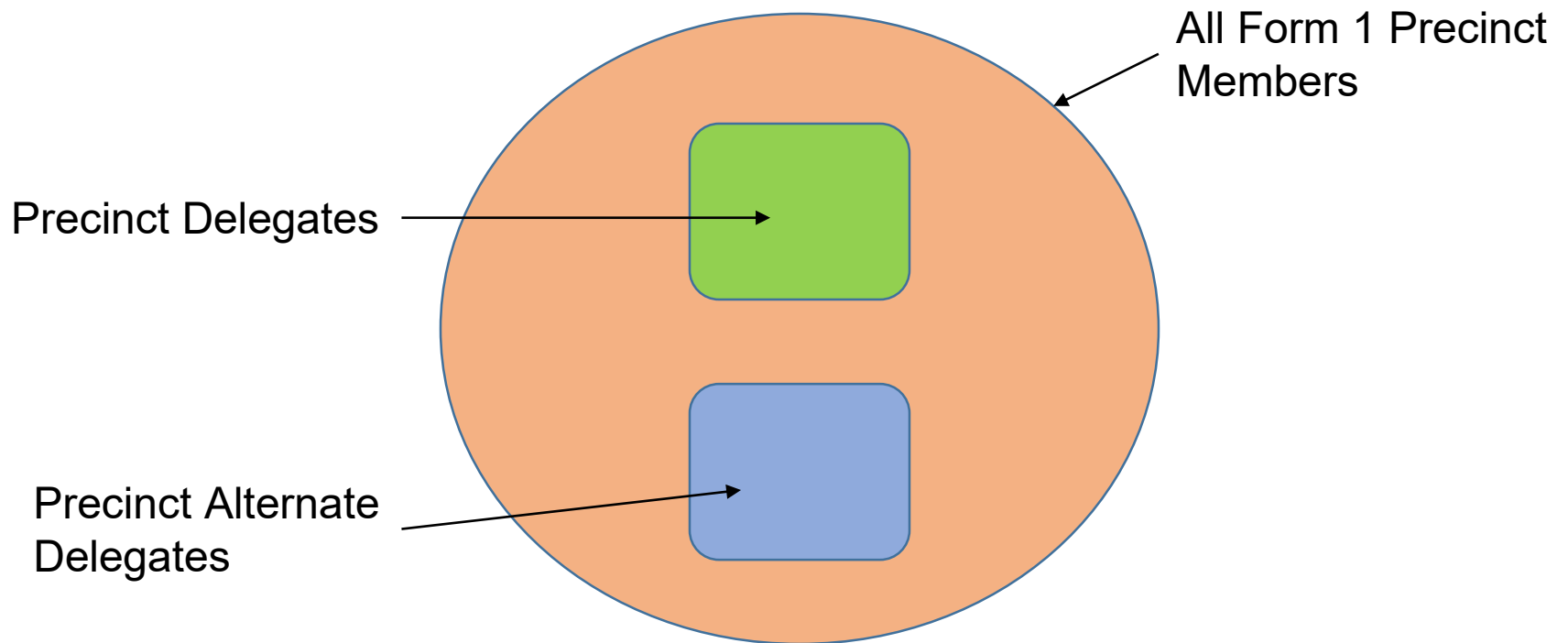

Precinct Meeting – Kickoff and New Delegate Elections

- Ask for who wants to be a precinct delegate to attend County Convention
- Motion to accept those who want to be a precinct delegate to County Convention.
- For example, if there is a 10 delegate allotment, then 10 delegates and 10 alternate delegates are elected. The remaining people are “Form 1 members”
- If there are more people than delegate slots, a nomination and voting process must be used.
- If less people than delegate slots, then a motion to bring in all attendees as delegates can be made and voted on.
- IF you were elected to be a precinct delegate, check boxes 1 and 3
- IF you do not want to be a precinct delegate, just check box 1 only.
- IF you attend the Reorg Makeup meeting and were elected to be a precinct delegate, check box 2. DO NOT USE BOX 2 unless you attend the Reorg Makeup meeting on 3-29

Precinct Meeting - New Officer Elections

- All Delegates, Alternate Delegates, and any extra Form 1 members now get to vote for new officers
- Nominate and Elect new Executive Commiteeman
- Nominate and Elect new President
- Nominate and Elect new Vice President
- Nominate and Elect new Secretary
- Functions of Officers listed in Packet
- Newly elected officers do not take control of precinct until AFTER convention



2023 SCGOP Precinct Reorganization Guide

Descriptions of Precinct Officers

President

- Sets meetings for precincts
- Presides at precinct meetings
- Arranges for precinct reorganization
- Attends County Executive Committee meetings

County Executive Committeeman

- Votes on behalf of the precinct at County Executive Committee meetings
- Maintains contact with and reports to the precinct members when appropriate
- Must be willing to attend County Executive Committee meetings monthly

Secretary

- Keeps meeting records/minutes
- Keeps a list of precinct members
- Maintains contact with and reports to the precinct when appropriate

Treasurer

- Receives, disburses, and accounts for funds generated by the precinct

Vice-President

- Fills in for President when necessary

Delegate to County Convention

- Attends County Convention and any subsequent meetings in order to vote on business matters related to County Convention and District Convention.

Closeout of Precinct Meeting

- IMPORTANT! If you want to be on the ballot to be elected as a County Delegate to the State Convention held in MAY in Columbia, check the enclosed box now on your FORM 1 – election will be at County Convention for these 15 or so delegates
- Business/ Special Announcements (make sure everyone is reminded of County Convention date)
- Adjournment
- Make sure that “Form 1” has been completed by every person in attendance
- You should take a picture of your completed Form 1 before turning it in !!
- After Reorg, County Chair must verify the Form 1’s and sign a Form 2 verifying all the information is correct

Follow Up Guidelines

- Precinct President with help from Secretary should verify that all “Form 1’s” have been *properly completed* according to the outcome of the election
- Precinct President should complete “Form 2” according to the outcome of the election
- Need to recruit more good Conservatives if your precinct delegate slots and alternate slots weren’t filled
- Precinct President should call/ email elected Delegates and Alternates to remind them about County Convention

Reorg Make Up Meeting

- Should be at (1) central location – ours will be at Gignilliat Center in Seneca on March 29th, two weeks after the reorg
- Purpose of Reorg Make Up is to:
 - Organize those Precincts that were not done so at the initial Reorg meeting
 - Add precinct members to fill precinct delegate and alternate delegate slots in already-organized precincts, that were not already filled
 - Add Form 1 members to precincts which have already filled delegate slots
- Information should be sent to SCGOP within (3) days of the meeting (SCGOP Rule 4-c-9)

County Convention

- Must be held during the month of April at least 5 days after the make-up meeting
- Precinct Delegates Attend, Alternate Delegates any missing Delegate slots if Delegate absent.
- Ours is scheduled for Saturday, April 5th, at approximately 9am at Gignilliat Center in Seneca
- County Officers are elected at County Convention
 - County Chairman
 - 1st Vice Chairman
 - State Executive Committeeman
- State Convention Delegates and Alternates are elected by who gets most precinct delegate votes (the number is based on population) (Oconee County was allotted 15 in 2023 – should be about the same in 2025)
- OCC WILL HAVE SEPARATE TRAINING ON THE CONVENTION IN LATE MARCH
